- 5.4. Village green and long term maintenance The village green in South Kilvington is owed privately by a family. A number of the trees situated on the green are in need of maintenance. The Parish Council have written to the land agents of the owners requested that the maintenance of any dangerous trees is made a top priority. SKPC have also requested copies of any formal agreements that are in place between the Parish Council and owners of the green.
- 5.5. River monitoring The data currently been held about Cod Beck is outdated and Cllr Martin is trying to get more up to date information. Cllr Martin also been in contact with Friends of Cod Beck and Friends of Earth Thirsk. Plans to undertake some Balsam Bashing however currently the wrong tome of the year. Cllr Martin also in communications with the Environmental Agency to obtain more up to date info. Also looking at obtaining fish data to understand the health of the fish population.
