## 2. Minutes of the last Parish Council meeting

The minutes from the meeting held on 23rd November 2021, having been previously circulated, were approved and signed.

## 3. Matters arising

- 3.1** Speeding update – further research surrounding the ability to install a speeding matrix sign. It may be possible to obtain funding from 'North Yorkshire, Police, Fire and Crime Commissioner – community fund grant'. The Parish Council need to establish the order into which to undertake the necessary permissions and obtaining quotes, this matter is still ongoing.
- 3.2** Queens Green Canopy - As part of the Queens jubilee – application for a jubilee to be planted on the village green and permissions had been granted. Expected to be planted February/March 22.
- 3.3** Jubilee Village celebrations – An informal 'Tea of the Green' to be co-ordinated for Friday 3<sup>rd</sup> June 2022 – approx. start 2pm – all residents of the village to be asked to bring picnic blankets, chairs and bunting etc. Villagers to provide their own food and drink. Then it is anticipated that the school and church will organise a summer event in due course.
