- It is understood that the developers will be looking at submitted an appeal to the planning decision.
- The developers have also asked to attend the next Parish Council Meeting. The members of Beck lane have asked that any new information is made available to the parish council for onward distribution at least 7 days before the meeting.
- Cllr Martin to look and discuss situation with Friends of Thirsk and others interested in preserving Cod Beck etc.

 it has been decided that the parish councillors will meet privately to discuss a parish charter,
 develop a communications strategy and also develop an internal policy for dealing with
 planning policies etc. This will be reported back at the next meeting.
