5. Matters arising

- 5.1. Beck Lane Planning 23/00243/OUT this went into the appeals process and planning permission has now been granted.
- 5.2. The bridal way over Cod beck has been closed. The Parish Council have been in contact with North Yorkshire footpaths. It is unlikely that the bridge will be repaired in this financial period. The footbridge will be removed at the end of July and a footpath diversion will be put in place by the end of July. The footpath diversion from the village will go up Stockton Road to the roundabout, along the A168 and cut back down Northallerton Road where the footpath crosses the road.

A new approach to managing speed limits in North Yorkshire

Feedback from Cllr Duncan, (Executive Member for Highways and Transportation, Road Safety and Cycling/Active Travel Champion)

Cllr Duncan added: "What started as a review into 20mph limits became more encompassing, as we looked seriously at ways to improve the way we set speed limits generally"

"Following cross-party feedback and a review of experiences elsewhere, we are not proposing to introduce 20mph as the default speed limit in every town and village."

The view taken by SKPC differs to that of North Yoskhire.

5.4. Vehicle Activated Sign (VAS) - The posts have been erected at either end of the village now and are ready for the PC to purchase a VAS.

Cllr Hitchin - has done further research into the VAS. Cllr Hitchen presented a number of options to the PC and subject to the financial position of the PC all agreed that the system from SWARC seemed to be the best option for South Kilvington and the PC, its was also noted to be a local company and provides a laptop and VAS can have variable speed limits etc.

5.5. River Monitoring – Cllr Martin met with Charlotte Simmons from the Yorkshire Dales river trust and did a river walk. The river stones were quite grey etc. The Environmental Agency (EA) does monitor the water at Cod Beck – near the mill race – the EA data is well out of date and last updated December 2021. River Trust have maps of where sewage enters the river – Effluent from licensed properties in the area.

Cllr Martin is going to monitor the Cod Beck, and members of the community are actively encouraged to report any river pollution or issues etc. Cllr Martin is going to look into engaging the community and Friends of Thirsk on this issue.
